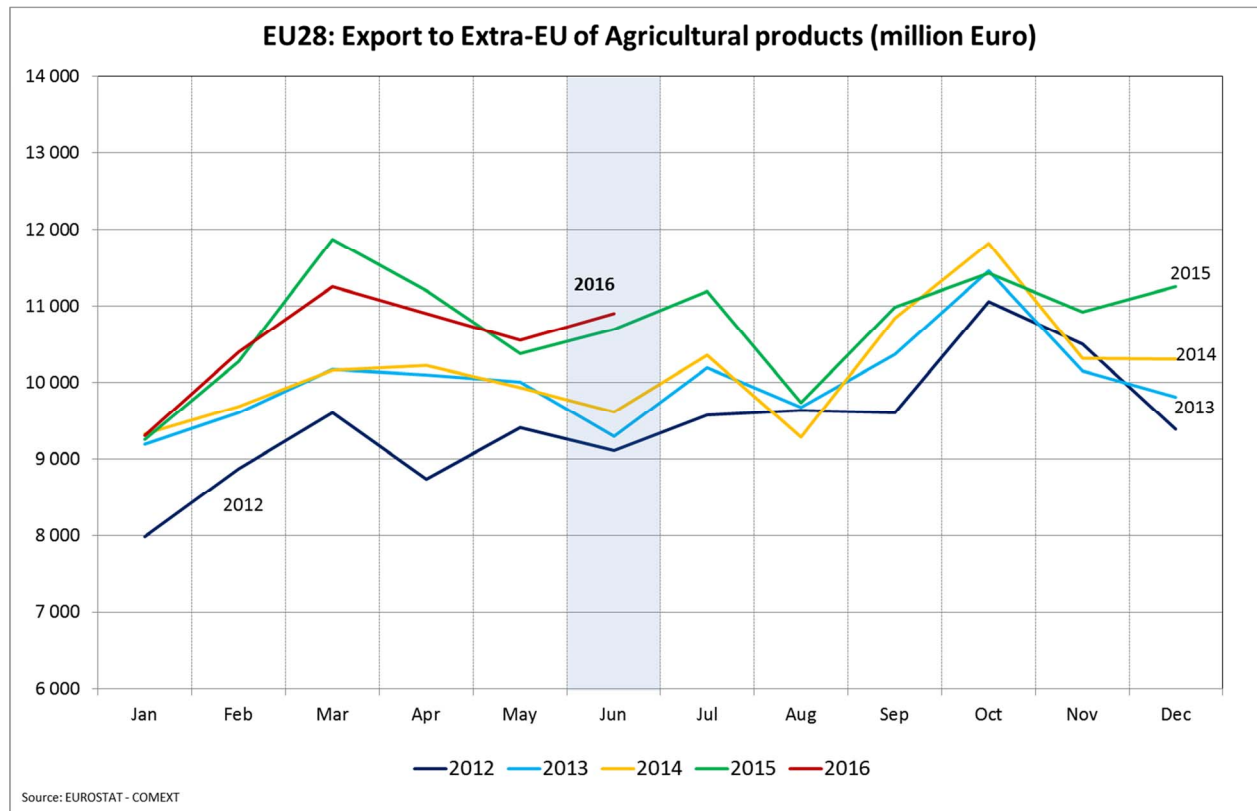


Monitoring EU Agri-Food Trade: Development until June 2016



June 2016 – growing surplus in EU agri-food net trade

The monthly value of EU agri-food exports in June 2016 reached EUR 10.9 billion and, thus, slightly exceeded the export values in June of previous years.

EU agri-food imports went down from EUR 9.8 billion in June 2015 to EUR 9.5 billion in June 2016; thus the net trade surplus increased from EUR 869 million (June 2015) to EUR 1 388 million (June 2016)

Highest increases in EU monthly export values (June 2016 compared to June 2015) were recorded for the **China** (EUR +130 million), **USA** (EUR +53 million) and **Libya** (EUR +49 million, mainly grains). Also, agri-food exports to Saudi

Arabia, Vietnam, Israel and Turkey increased by EUR 30 million or more. Most important reductions were in export values to Egypt, Algeria and Nigeria.

The highest increases in monthly export values were achieved for **pork** (+58%), followed by meat offal and infant food.

On the other hand, monthly export values in June 2016 compared to June 2015 went down in particular for raw hides and skins, for spirits and liqueurs, and for milk powders.

The highest increase in monthly import values was from Ivory Coast and Ghana (cocoa beans), while imports from Brazil and USA lost most in value terms.

12-month period: High increase in agri-food exports to USA

For the 12-months period July 2015 to June 2016, EU agri-food exports reached a value of more than EUR 129 billion, corresponding to an increase by 2.1% in value terms compared to the same period one year ago.

Major gains were achieved in values of agri-food exports to the **USA** (EUR + 2.2 billion; +12%) and **China** (EUR +1.8 billion; +20%), followed by increases in exports to **Saudi Arabia** (EUR +0.6 billion). Agri-food exports to Switzerland, the United Arab Emirates, Israel and Australia, each increased by more than EUR 200 million in the twelve-months period. Exports to **Russia** further went down, from EUR 6.6 billion (July 2014 to June 2015) to EUR 5.6 billion (July 2015 to June 2016), i.e. a reduction in values by 16%, but also exports to **Hong Kong** went down by EUR 1.2 billion (-24%) over this period.

Analysing the performance over the last twelve months per product category, export values increased in particular for **pig meat** (EUR +986 million; +26% compared to export values in the 12-months period one year ago, with an increase by EUR +188 million in June 2016 compared to June 2015), **wine** (EUR +511 million; +5%), **live animals** (EUR +502 million; +24%) and fresh, chilled or dried **vegetables** (EUR +403 million; +15%). In relative terms, high increases in export values were also seen for butter and eggs.

Similar to the development recorded for May, **raw hides and skins** (EUR -1.1 billion; -36%), **wheat** (EUR -1.0 billion; -15%) and **milk powders** (EUR -695 million; -16%) lost most in export values over the last 12 months. Reductions in export revenues were also noted for other cereals, poultry meat and fresh fruit.

Major reduction in agri-food import values from Brazil

Agri-food imports from third countries in the period July 2015 to June 2016 came into the EU at a value of EUR 113 billion, i.e. an increase by 3.5% compared to the same period one year ago. The export surplus for the 12-months period stands at almost EUR 17 billion.

The value of agri-food imports from **Brazil** decreased by EUR 1.3 billion (-10%) in the 12-months period until June 2016. Imports from other important suppliers, Indonesia and Canada also went down compared to the previous 12 months period. Moreover, imports from Tunisia (olive oil) went down by almost EUR 100 million.

On the other hand, imports from **Ukraine** showed the highest increase in value terms (EUR +831 million; +23%), still increasing in the last month. Over the last 12 months, EU import values for agri-food products went up for **Argentina** by EUR 675 million (+13%), for **Ivory Coast** by EUR +664 million (+26%), Turkey (EUR +367 million; +8%), Australia (EUR +316 million; +18%), Peru (EUR +283 million; +16%), USA (EUR +268 million; +2%) and for Colombia (EUR +223 million). Also imports from Chile, South Africa and Russia improved.

Looking at imports per product category, the highest increase in values over the last 12 months was for **tropical fruit, nuts and spices** (EUR +1.3 billion; +10.5%). Imports also increased particularly for cocoa beans (EUR +682 million; +21%), oilseeds other than soya beans (EUR +624 million; 23%), cereals other than wheat (EUR +555 million; +28%) and for fresh, chilled or dried fruit and vegetables.

On the other hand, import values decreased in particular for commodities such as unroasted coffee and tea in bulk (EUR -694 million; -6%), **oilcakes** (EUR -958 million; -12%), palm oil, palm kernel and coconut oil (EUR -367 million; -6.5%), fruit juices (EUR -153 million; -6.5%), raw tobacco (EUR -153 million) and casein and modified starches (EUR -144 million).
