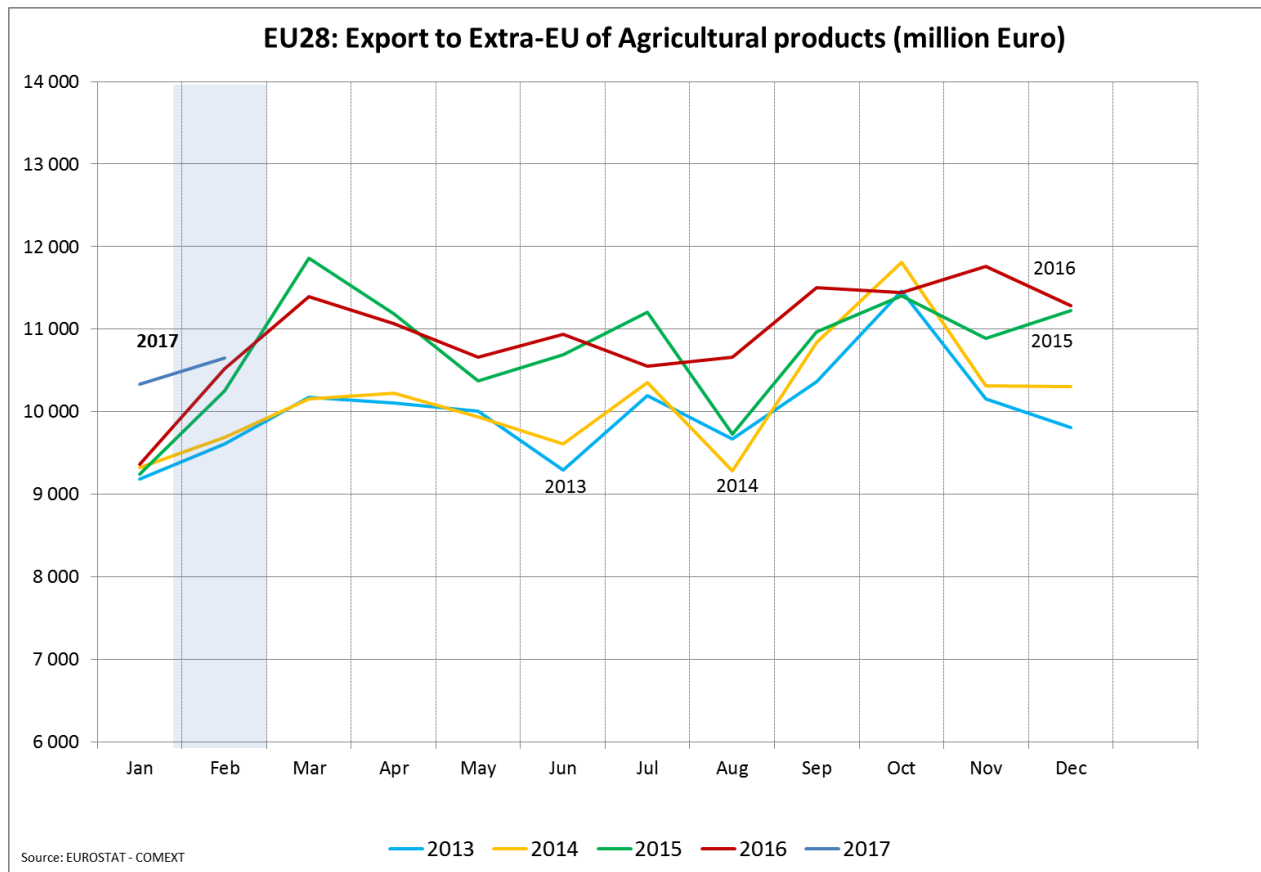


## Monitoring EU Agri-Food Trade: Development until February 2017



### EU agri-food exports of non-banned products to Russia resuming slightly

The monthly value of EU agri-food exports in February 2017 reached a value of almost EUR 10.7 billion, which is EUR 131 million (+1.2%) higher than in February 2016.

Highest increases in monthly export values (Feb 2017 compared to Feb 2016) were recorded for **Russia** (EUR +86 million), **China** (EUR +77 million), the **USA** (EUR +58 million) and Korea (EUR +55 million). Other major gains in EU agri-food exports were in Angola, Japan, India, Hong Kong and Ukraine.

Monthly exports to **Saudi Arabia** reduced most in value terms (EUR -94 million), followed by Egypt (EUR -76 million), Turkey, Morocco and Ethiopia.

Among all products, **wine** and **pigmeat** were the biggest winners in monthly export values, while wheat and other cereals further reduced in value terms.

Monthly values for EU agri-food **imports** also increased in February 2017 compared to the year before (EUR +133 million; +1.5%). Imports from Brazil and Indonesia increased most, while imports from Argentina and the USA went down most. Major increases were seen in soybeans, other oilseeds and coffee, while imports in oilcakes went down.

With monthly exports and imports increasing by about the same value, the **trade balance** in February 2017 did not change compared to February 2016.

## US and Asian export markets growing further

For the 12-months period March 2016 to February 2017, EU agri-food exports reached a value of EUR 132.2 billion, corresponding to an increase by 2.2% in value terms compared to the same period one year ago.

Major gains were achieved in values of agri-food exports to the **USA** (EUR + 1.2 billion; +6%) and **China** (EUR +1.0 billion; +10%), although exports to Hong Kong went down significantly. Increases were also recorded in agri-food exports to **Japan** (EUR +0.5 billion) and **Korea** (EUR +0.4 billion). Exports to Switzerland, Russia (for non-banned products), Israel and Ukraine, each increased by more than EUR 200 million in the twelve-month period. The development in EU exports values to Russia is linked to the economic recovery and the strengthening of the Russian ruble in recent months.

Apart from **Hong Kong** (EUR -544 million; -13%), export values also went down for **North African** and **Middle East** destinations, such as Algeria (EUR -480 million; -16%), Morocco (EUR -479 million; -22%) and Saudi Arabia (EUR -425 million; - 9%), in particular due to a reduction in values of cereals exports.

Analysing the EU export performance per product category over the last twelve months, export values reflect in particular the recovery in **pig meat** exports (EUR +1.35 billion; +33% compared to export values in the 12-months period one year ago), **meat offal**, other meat and fat (EUR +556 million; +23%), **infant food** and other preparations of cereals, flour, starch or milk (EUR +461 million; +7%) **wine** (EUR +436 million; +4%), and **olive oil** (EUR +352 million; +15%).

Similar to the development recorded for previous periods, **other cereals** (EUR -1.0 billion; -36%), **raw hides and skins** (EUR -921 million; -36%), **wheat** (EUR -857 million; -14%) and **milk powders** (EUR -508 million; -12%) lost most in export values over the last 12 months.

## EU trade surplus in agri-food at EUR 19 billion over 12 months

Agri-food imports from third countries in the 12-months period March 2016 to February 2017 came into the EU at a value of EUR 113 billion, i.e. a decrease by 0.9% compared to the same period one year ago. The export surplus for the 12-months period thus increased to almost EUR 19 billion.

Main origins for EU agri-food imports over the past 12 months were Brazil, USA, Argentina and China, followed by Switzerland, Turkey, Indonesia, Ukraine and Ivory Coast.

On the year-on-year basis, the value of agri-food imports from **Ivory Coast** increased most (EUR +378 million, +11.5%). Despite a reduction in the month of November 2016, imports from **Peru** also showed an important increase in annual value (EUR +234 million; +12%). Over the 12 months period, EU import values for agri-food products also went up for **Vietnam** (EUR +196 million; +9%), **Costa Rica** (EUR +190 million; +12%), **Madagascar** (EUR +162 million; +70%), and **Morocco** (EUR +144 million; +8%).

On the other hand, the value of agri-food imports from **Brazil** decreased by EUR 1.2 billion (-9%) and imports from other important suppliers, the USA, Turkey, New Zealand and Malaysia went down compared to the previous 12 months period.

Looking at imports per product category, the highest increase in values over the last 12 months was for **cocoa beans** (EUR +840 million; +21%). Imports also increased in particular for vegetables (EUR +444 million; +10%), oilseeds other than soya beans (EUR +348 million; +11%), and citrus fruit (EUR +290 million; +16%).

On the other hand, import values decreased in particular for commodities such as **oilcakes** (EUR -1.1 billion; -13%), and raw tobacco (EUR -394 million; -15%).

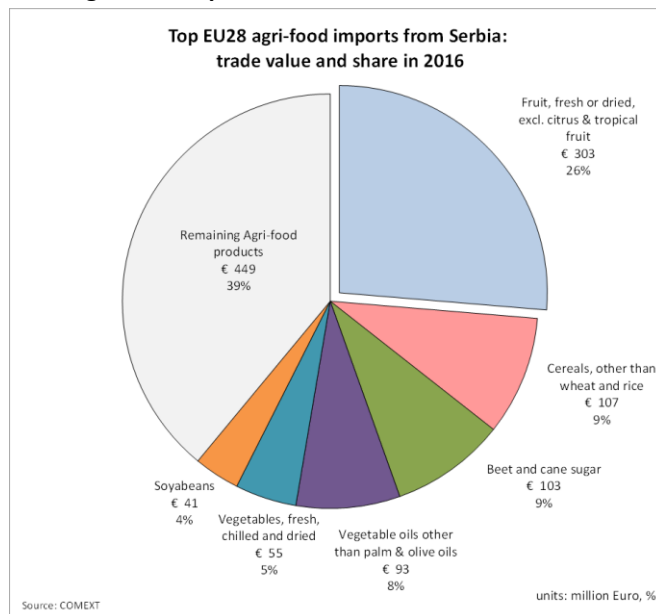
## Focus on: EU agri-food trade with Serbia

The EU is a net-importer of agri-food products from Serbia, with a trade deficit of around EUR 200 million in recent years. Exports to Serbia increased slowly over the past years, and also imports increase at about the same level. Serbia stands at rank 31 for all EU agri-food export destinations and is No 28 for import origins.

While the EU is more oriented towards exporting processed products, the imports from Serbia are mainly commodities and other primary products.

In 2016, the EU imported in particular fresh or dried fruit (EUR 303 million in 2016), cereals (EUR 107 million), sugar (EUR 103 million) and vegetable oils (EUR 93 million). Main EU export products were food preparations (EUR 78 million), chocolate and confectionary (EUR 56 million), but also fruit, pigmeat and cereals preparations such as pasta and pastry.
