Labour costs in the EU

# Hourly labour costs ranged from €4.1 to €41.3 across the EU Member States in 2015

Lowest in Bulgaria and Romania, highest in Denmark and Belgium


In 2015, average hourly labour costs in the whole economy (excluding agriculture and public administration) were estimated to be  $\in$ 25.0 in the **European Union** (EU) and  $\in$ 29.5 in the **euro area**. However, this average masks significant gaps between EU Member States, with the lowest hourly labour costs recorded in **Bulgaria** ( $\in$ 4.1), **Romania** ( $\in$ 5.0), **Lithuania** ( $\in$ 6.8), **Latvia** ( $\in$ 7.1) and **Hungary** ( $\in$ 7.5), and the highest in **Denmark** ( $\in$ 41.3), **Belgium** ( $\in$ 39.1), **Sweden** ( $\in$ 37.4), **Luxembourg** ( $\in$ 36.2) and **France** ( $\in$ 35.1).

In industry, labour costs per hour were €25.9 in the **EU** and €32.3 in the **euro area**, in services €24.9 and €28.6 respectively and in construction €22.4 and €25.8. In the mainly non-business economy (excluding public administration), labour costs per hour were €25.1 in the **EU** and €29.4 in the **euro area** in 2015.

Labour costs are made up of wages & salaries and non-wage costs such as employers' social contributions. The share of non-wage costs in the whole economy was 24.0% in the **EU** and 26.0% in the **euro area**, ranging from 6.6% in **Malta** to 33.2% in **France**.

These estimates for 2015 come from an <u>article</u> issued by **Eurostat, the statistical office of the European Union**. Data cover enterprises with 10 or more employees and are based on the Labour Cost Survey data for 2012, which are extrapolated through the Labour Cost Index.

#### Decreases in hourly labour costs in Cyprus and Italy

Between 2014 and 2015, hourly labour costs in the whole economy expressed in € rose by 2.0% in the EU and by 1.5% in the euro area.

Within the euro area, the largest increases were recorded in Latvia (+7.3%), Lithuania (+5.6%) and Estonia (+5.3%). Decreases were observed in **Cyprus** (-1.0%) and **Italy** (-0.5%).

For Member States outside the euro area in 2015, and expressed in national currency, the largest increases in hourly labour costs in the whole economy between 2014 and 2015 were registered in Romania (+8.3%) and Bulgaria (+7.0%), and the smallest in **Denmark** and **Croatia** (both +1.7%). When comparing labour cost estimates in € over time, it should be noted that data for those Member States outside the euro area are influenced by exchange rate movements.

#### Geographical information

The European Union (EU) includes Belgium, Bulgaria, the Czech Republic, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland, Sweden and the United Kingdom.

The euro area includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

#### Methods and definitions

Total Labour Costs cover wage and non-wage costs less subsidies. They do not include vocational training costs or other expenditures such as recruitment costs, spending on working clothes, etc.

Wage and salary costs include direct remunerations, bonuses, and allowances paid by an employer in cash or in kind to an employee in return for work done, payments to employees saving schemes, payments for days not worked and remunerations in kind such as food, drink, fuel, company cars, etc.

Non-wage costs include the employers' social contributions plus employment taxes regarded as labour costs less subsidies intended to refund part or all of employer's cost of direct remuneration.

The whole economy (except agriculture and public administration) includes NACE Rev. 2 sections B to N and P to S, and can be subdivided into the following economic activities:

- The business economy, which includes NACE Rev. 2 sections B to N; for the EU and euro area this accounts for about 76% of the labour costs of the whole economy. It can be further broken down into:
  - Industry, which includes: Mining and quarrying; Manufacturing; Electricity, gas, steam & air conditioning supply; and Water supply, sewerage, waste management & remediation activities. Industry accounts for around 22% of the whole economy.
  - Construction, which accounts for around 6% of the whole economy.
  - Services, which include: Wholesale and retail trade, repair of motor vehicles & motorcycles; Transportation & storage; Accommodation & food service activities; Information & communication; Financial & insurance activities; Real estate activities; Professional, scientific & technical activities; Administrative & support service activities. Services account for around 48% of the
- The mainly non-business economy (except public administration), which includes NACE Rev. 2 sections P to S; for the EU and euro area this accounts for about 24% of the labour costs of the whole economy. It includes Education; Human health & social work activities; Arts, entertainment & recreation; and Other service activities.

Labour costs data presented in this News Release cover enterprises with 10 or more employees and include apprentices.

Labour cost data for the years 2004, 2008 and 2012 come from the Labour Cost Survey. Estimates for years after 2012 are obtained by extrapolating the 2012 Labour Cost Survey hourly labour cost data expressed in national currencies using the Labour Cost Index (LCI) transmitted by the Member States. In order to calculate monetary estimates in € and to derive European aggregates, exchange rate movements have to be incorporated. For this purpose, an exchange-rate adjusted LCI index is calculated for non-euro area countries. The LCI not adjusted for calendar effects is used except for Denmark, France and Sweden where only calendar-adjusted data are available.

#### Country notes:

France: the aggregate shown for the whole economy for 2008 also excludes NACE Rev. 2 section P (Education).

Italy: data up to 2012 are not strictly comparable over time due to methodological breaks.

France and Austria: data for 2013, 2014 and 2015 are taken from national sources.

Denmark: data for 2013 and 2014 are taken from national sources.

Spain and Romania: data for 2014 is taken from national sources.
